1. ACCURACY OF INFORMATION

I, the undersigned, hereby declare and warrant that all information and supporting documentation provided in this application for membership with a chapter of the Kamra tal-Periti ("KTP") are true, complete, and accurate to the best of my knowledge. I acknowledge that KTP may rely on this information when assessing my application and that any material misstatement, omission, or misrepresentation may result in refusal of my application or subsequent termination of membership.

2. CONSENT TO PROCESSING OF PERSONAL DATA

I hereby freely, specifically, and unambiguously consent to the collection and processing of my personal data by KTP for the sole purposes of:

- (i) administering and assessing this application;
- (ii) establishing and managing my membership within the relevant chapter, if admitted;
